Pursuant to Regulation 7(2) read with Regulation 6(2) of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, we have been informed that Mr. Astik Mani Tripathi, the promoter of the company acquired 10,000 equity shares of the Company on January 21, 2026, resulting in a post-acquisition shareholding of 3.127% of the paid-up equity share capital of the Company.

Further, Mrs. Urmila Tripathi, a member of the Promoter Group, acquired 2,400 equity shares of the Company during the period from January 5, 2026 to January 14, 2026 and disposed of 600 equity shares on January 14, 2026. Additionally, she acquired 2,200 equity shares of the Company from January 20, 2026 to January 21, 2026. After the aforesaid acquisition and disposal of shares, her shareholding stands at 0.050% of the paid-up equity share capital of the Company.
